We are holding this fundraising event to support the Children's Center for Cancer & Blood Diseases of Las Vegas. The clinic was established in September of 2006 by Dr. Jonathan Bernstein with the goal of creating Nevada's first non-profit, multi-disciplinary childhood cancer center; where children can not only receive medical care but also have access to clinical trials regardless of their parents' ability to pay for services. Some event proceeds will be allocated to the Burn Foundation so that it may continue helping the community with future events and fundraisers.
